LET THE RECORD REFLECT that the Defendant's mother and legal guardian is present in the courtroom.

Discussion is held.

The report by Dr. Bruce Hamstra dated January 14, 2009 having been considered,

THE COURT FINDS that the Defendant remains incompetent to stand trial and also finds that there is a substantial probability that the Defendant will regain competency within the foreseeable future.

THEREFORE, IT IS ORDERED that the Defendant continue to receive treatment necessary to regain competency at the Maricopa County Correctional Health Services Restoration to Competency Program for up to an additional 30 days from the date of this hearing.

IT IS FURTHER ORDERED that the treatment facility/program shall submit to this Court a written report by **02/19/09** unless a prior determination is made regarding the defendant's competency. Upon determination being made, the treatment provider shall immediately notify this Court's Forensic Services Administrator (506-3916).

The Court admonishes the Defendant to show effort during the restoration process.

IT IS FURTHER ORDERED setting a further nonevidentiary Status Hearing concerning the issue of competency on **February 26, 2009 at 9:00 a.m.** before Judge Pro Tem Brian Rees, 201 W. Jefferson St., CCB-13th Floor, Courtroom 1303, Phoenix, AZ 85003.

The Court is informed that the Defendant is currently not enrolled with Magellan Health Services and is not receiving services.

IT IS FURTHER ORDERED affirming prior custody orders.
