The Court finds that Defendant violated the conditions of probation imposed on 03/28/2001 on the following charge (s):

IT IS ORDERED the grant of probation be revoked.

IT IS ORDERED that Defendant be committed to the Arizona Department of Corrections for a term of imprisonment as follows:

Sentence is concurrent with CR2000-018991 and Count 3 in CR2003-037510-001 SE.

IT IS ORDERED affirming the amount of restitution previously ordered (\$625.04), with credit for monies paid to date. Restitution to be paid at 30% of Defendant's earnings while incarcerated in DOC.

IT IS FURTHER ORDERED that payments shall be made at the rate of \$25.00 per month beginning the 1st day of the 3rd month upon release from DOC confinement in Count 3 of CR2003-037510-001 SE.

IT IS FURTHER ORDERED that Defendant pay a time payment fee pursuant to A.R.S. § 12-116 in the amount of \$20.00.

All amounts payable through the Clerk of the Superior Court.

The Arizona Department of Corrections shall notify the Clerk of the Court of Maricopa County of Defendant's release from custody. The Clerk of the Court, upon said notification, shall furnish financial information for a Criminal Restitution Order for Judicial signature for any unpaid monies to date.

Community Supervision: Waived pursuant to A.R.S. § 13-603(K) and 41-1604.07(D), due to the term of probation in CR2003-019950-001 and Count 1 in CR2003-037510-001 SE.

IT IS ORDERED that Defendant still be eligible to earn early release credits even though Community Supervision was waived.

IT IS ORDERED authorizing the Sheriff of Maricopa County to deliver the Defendant to the Arizona Department of Corrections to carry out the term of imprisonment set forth herein.

IT IS ORDERED the Clerk of the Superior Court remit to the Arizona Department of Corrections a copy of this order together with all presentence reports, probation violation reports, and medical and psychological reports that are not sealed in this cause relating to the Defendant.

The probation violation report is filed under CR2003-037510-001 SE.
