Report to the APD within 72 hours of release from jail. Comply with all program rules.

Defendant is eligible for Work Release.

The Defendant shall be released Monday through Sunday (7 days/week) from 6:00 a.m. until 9:00 p.m. on Work Release.

Condition 24 - Participate and cooperate in any counseling or assistance as directed by the APD as noted in the Uniform Conditions of Supervised Probation.

Condition 26 - Other: The Defendant shall report to APO as directed by APO while on Work Release.

IT IS ORDERED granting the Motion To Dismiss the following: Counts 6, 7 and 8 and allegation of dangerousness for sentence enhancement purposes but not for aggravation.

Count(s) 1: IT IS ORDERED Defendant self-surrender on May 4, 2009 by 9:00 p.m. to the custody of the Maricopa County Sheriff and authorizing the Sheriff to carry out the term of incarceration.

IT IS FURTHER ORDERED that Defendant must submit to Deoxyribonucleic Acid (DNA) testing for law enforcement identification purposes and pay the applicable fee for the cost of that testing in accordance with A.R.S. § 31-281.

The Defendant's driving privileges shall be revoked.
