Condition 18 - Not have any contact with the victim(s) whatsoever, unless approved in writing by the Adult Probation Department.

Condition 21 - Count 1: Be incarcerated in the county jail for 60 day(s), beginning to be determined on July 8, 2010 at incarceration review hearing.

Report to the APD within 72 hours of release from jail. Comply with all program rules.

Defendant is eligible for Work Release.

IT IS ORDERED exonerating any bond previously posted in this matter to the party posting same.

IT IS FURTHER ORDERED that Defendant must submit to DNA testing for law enforcement identification purposes and pay the applicable fee for the cost of that testing in accordance with A.R.S. § 13-610.

IT IS ORDERED setting incarceration review hearing from July 8, 2010 at 1:30 p.m. in EAST COURT BUILDING courtroom 512 before the Honorable Timothy Ryan.
