Count 3 Probation Term: 5 Years

To begin upon physical release from prison in Count 1.

Conditions of probation include the following:

Condition 16 - Restitution, Fines, and Fees:

PROBATION SERVICE FEE: Count 3 - \$50.00 per month.

Payment shall commence on the first day of the second month upon release from supervision of the Arizona Department of Corrections.

All amounts payable through the Clerk of the Superior Court.

The Court will retain jurisdiction over restitution. A Restitution Hearing is set for October 15, 2007 at 8:30 a.m. in this division. Defendant waives his presence.

Condition 17 - Not consume or drink any substance containing alcohol.

Condition 18 - Not have any contact with the victim(s) whatsoever, unless approved in writing by the Adult Probation Department.

Condition 24 - Participate and cooperate in any counseling or assistance as directed by the APD as noted in the Uniform Conditions of Supervised Probation.

Condition 25 - Abide by the Special Conditions of Probation as noted on the attachment to the Uniform Conditions of Supervised Probation.

Condition 26 - Other: The Court retains jurisdiction over matters of restitution in this Count (3), so any further restitution matters can be settled.

IT IS ORDERED exonerating any bond previously posted in this matter to the party posting same.

IT IS FURTHER ORDERED the Defendant is to submit to immediate testing for blood borne diseases with results immediately provided to the affected Victim in Count 2, Officer Michael Lancaster of the Chandler Police Department.

IT IS FURTHER ORDERED that Defendant must submit to Deoxyribonucleic Acid (DNA) testing for law enforcement identification purposes and pay the applicable fee for the cost of that testing in accordance with A.R.S. §31-281.
