IT IS ORDERED vacating any pending dates.

Defendant's Motion to Modify Release Conditions is argued.

IT IS ORDERED releasing defendant to the third-party custody of her parents, James Day and Kimberly Day and under the supervision of Pretrial Services with electronic monitoring.

Defendant shall not be released from custody until or unless it is verified by Pretrial Services that electronic monitoring is available at the home.
