Pursuant to A.R.S. § 13-3401, the Court finds the aggregate amount of drugs is less than the statutory threshold amount.

IT IS ORDERED suspending imposition of sentence and placing defendant on Unsupervised Probation to be monitored by the Adult Probation Department (APD):

Count 2 as amended Probation Term: 12 months

To begin August 26, 2005.

Conditions of probation include the following:

Condition 10 - Complete a minimum of 8 hours of drug education and provide verification to APD within 90 days of sentencing. Refer to Term #19 below.

Condition 16 - Restitution, Fines, and Fees:

PROBATION SERVICE FEE: Count 2 as amended - \$50.00 per month, beginning October 1, 2005.

FINE: Count 2 as amended - Total amount of \$750.00, payable \$75.00 per month beginning October 1, 2005. Surcharges are waived.

Fine is to be paid to the Arizona Drug Enforcement Fund.

ASSESSMENTS:

Count 2 as amended: Time payment fee pursuant to A.R.S. § 12-116 in the amount of \$20.00.

Count 2 as amended: PROBATION SURCHARGE: \$5.00

All amounts payable through the Clerk of the Superior Court.

Condition 19 - Count 2 as amended: Complete a total of 24 hours of community service work beginning August 26, 2005 at a minimum of 5 hours each month. Provide proof of completion to APD as stated in the written conditions of probation.

In lieu of 24 hours of community service, Defendant may instead complete 8 hours of drug education.

Condition 24 - Complete any programs of assistance as noted in the Unsupervised Probation Conditions.
