IT IS FURTHER ORDERED that Defendant must submit to DNA testing for law enforcement identification purposes and pay the applicable fee for the cost of that testing in accordance with A.R.S. § 13-610.

IT IS FURTHER ORDERED granting the motion to dismiss the following: Counts 1 and 2, the allegation of prior felony convictions, and the allegation of multiple offenses.
