IT IS THE JUDGMENT of the Court Defendant is guilty of the following:

OFFENSE: Count 1 First Degree Murder

Class 1 Dangerous Felony

A.R.S. § 13-301, 302, 303, 304, 1101, 1105, 3601, 701, 702, 751, 752 and 801

Date of Offense: On or between 7/11/11 and 7/12/11

Dangerous pursuant to A.R.S. § 13-704 - Non Repetitive

AS PUNISHMENT, IT IS ORDERED Defendant is sentenced to a term of imprisonment and is committed to the Arizona Department of Corrections as follows:

Count 1: DEATH from 11/15/17

Presentence Incarceration Credit: 2303 day(s)

See Jury/Sentencing Verdict

Community Supervision: Count 1 - Waived pursuant to A.R.S. § 13-603(K), due to the term of incarceration in Counts 2-5.

In the event the Defendant is released by the Department of Corrections on a temporary release basis, and a term of Community Supervision has been waived, the length of probation shall be extended to include the time of Defendant's temporary release, pursuant to A.R.S. §13-901(B).

IT IS FURTHER ORDERED that Defendant must submit to DNA testing for law enforcement identification purposes in accordance with A.R.S. §13-610.

IT IS ORDERED authorizing the Sheriff of Maricopa County to deliver the Defendant to the Arizona Department of Corrections to carry out the term of imprisonment set forth herein.

IT IS ORDERED the Clerk of the Superior Court remit to the Arizona Department of Corrections a copy of this Order or the Order of Confinement together with all presentence reports, probation violation reports, and medical and psychological reports that are not sealed in this cause relating to the Defendant.

Defendant has waived the preparation of a presentence report.
