THE COURT FINDS that the relevant financial factors required to be included, and the discretionary allowances and adjustments which the Court will allow, for a current calculation of child support pursuant to the Arizona Child Support Guidelines are set forth in the Child Support Worksheet dated March 21, 2005 as prepared by Expedited Services, which the Court hereby incorporates and adopts as its findings with respect to child support.

IT IS ORDERED that Petitioner/Father shall pay Respondent/Mother \$607.88 per month as and for child support, effective February 1, 2005.

IT IS FURTHER ORDERED approving and settling the Child Support Order and the Order of Assignment signed by the Court this date.
