Delgado, is present on his own behalf. Respondent, Patricia Ann Chavez, is neither present nor represented by counsel. Court Interpreter, Sandra Feijoo Negron, is present from Court Interpretation and Translation Services to translate the proceeding into the Spanish Language for Petitioner.

A record of the proceedings is made by audio and/or videotape in lieu of a court reporter.

Alvaro T. Delgado is sworn and testifies.

The Court has been presented with photocopies of birth certificates for the minor children, Alvaro Delgado-Trujillo (DOB: 04/13/2000) and Alejandro Delgado-Trujillo (DOB: 10/10/2001).

THE COURT NOTES that there is no father's name listed on the minor children's birth certificates.

THE COURT FURTHER NOTES that there is a related Guardianship Case in the Juvenile Court for the minor children in case number JG500657. Anita Messina was appointed as Guardian of the minor children on May 8, 2006.

It appears that the Guardianship Case may still be open in the Juvenile Court. The Court has not located any related Dependency Cases regarding the two (2) minor children. However, there is an open Guardianship Case.

THE COURT FURTHER NOTES that Respondent/Mother is currently incarcerated. The minor children were placed with Petitioner by Child Protective Services (CPS), who also assisted Petitioner in completing DNA testing. The results of the DNA testing are attached to the Petition.

THE COURT FURTHER NOTES that Anita Messina had filed to terminate the Guardianship in JG500657 and that Anita Messina did not appear at the hearing. The Petition for Termination of the Guardianship was dismissed.

Under the circumstances and due to Mother's incarceration,

THE COURT FINDS that it is appropriate for Mother to have no parenting time with the minor children at this time.

The Court will not enter any child support orders. There is no way for Mother to work since she is in prison.

IT IS ORDERED granting the Petition for Paternity, Child Custody, Parenting Time, and Child Support.

IT IS FURTHER ORDERED awarding sole custody of the minor children to Petitioner/Father.

IT IS FURTHER ORDERED that Mother shall have no parenting time with the minor children.

IT IS FURTHER ORDERED reserving jurisdiction to issue child support orders in the future if Mother is released from incarceration.

IT IS FURTHER ORDERED taking jurisdiction over the related Juvenile Guardianship Case, JG500657.

IT IS FURTHER ORDERED dismissing the Guardianship that was previously issued to Anita Messina.

IT IS FURTHER ORDERED revoking and rescinding any Letters of Guardianship that were previously issued to Anita Messina.

IT IS FURTHER ORDERED returning jurisdiction to the Juvenile Court for all further proceedings.

IT IS FURTHER ORDERED declaring Petitioner to be the natural father of the minor children all in accordance with the formal written Judgment and Order for Paternity and/or Child Custody and Parenting Time signed by the Court on March 2, 2012, and filed (entered) by the Clerk on March 2, 2012.

IT IS FURTHER ORDERED directing the Arizona Department of Vital Records to add the name of father, **Alvaro Policarpo Delgado Trujillo (DOB: 01/26/1981)**, to the birth certificates of the minor children, **Alvaro Delgado-Trujillo (DOB: 04/13/2000)** and **Alejandro Delgado-Trujillo (DOB: 10/10/2001)**.

FILED: Petitioner's Certificate of Completion: Parent Information Program Class.

RESOLVED: Paternity, child custody and parenting time.
