MINUTE ENTRY

A Default Hearing regarding Dissolution of Marriage having come before the Court this date,

THE COURT NOTES that the Amended Affidavit of Service provided by Petitioner, Shanda Williams, in open court indicates that the Summons and Petition for Dissolution of a Non-Covenant Marriage (Divorce) with Children were served upon Respondent, Joseph Williams, in South Carolina on May 9, 2006, but does not indicate whether the Petition for Dissolution was the Amended Petition for Dissolution filed on April 28, 2006.

LET THE RECORD REFLECT that R.J. Provost, Process Server appeared telephonically and has avowed on the record in open court that he served Respondent with the documents provided to him by Petitioner, but could not recall whether the documents stated "Amended."

LET THE RECORD FURTHER REFLECT that Petitioner testified under oath on the record in open court that the initial Petition for Dissolution of Marriage was served in Arizona on February 14, 2006, and that the Amended Petition was served by R.J. Provost in South Carolina on May 9, 2006.

Based upon the foregoing,

THE COURT FINDS that Petitioner hand wrote the word "Amended" on the Petition for Dissolution of Marriage filed on April 28, 2006 and that the omission by the Process Server on the Amended Affidavit of Service was an inadvertent oversight.

THE COURT FURTHER FINDS that Respondent was served with both the Alias Summons and Amended Petition for Dissolution in South Carolina on May 9, 2006.

The Court amends the Amended Affidavit of Service in open court to indicate that the Alias Summons and Amended Petition for Dissolution of a Non-Covenant Marriage (Divorce) with Children were served.

FILED: Amended Affidavit of Service.

THE COURT FURTHER FINDS good cause to grant the request for Respondent to have supervised parenting time with the minor child, Lena Grace Williams (DOB: 01/22/2001), as indicated in the Amended Petition for Dissolution of Marriage filed on April 28, 2006.

IT IS ORDERED awarding sole custody of the minor child to Petitioner with Respondent to have supervised parenting time with the minor child according to the terms of the Parenting Plan filed herein.

IT IS FURTHER ORDERED referring this matter to Expedited Services to supervise parenting time between Respondent and the minor child.

IT IS FURTHER ORDERED that Respondent shall pay any and all costs of the supervision.

IT IS FURTHER ORDERED that the parties shall comply with all orders and instructions of Expedited Services.

THE COURT FURTHER FINDS that all the statutory requirements have been met.

IT IS FURTHER ORDERED dissolving the parties' marriage all in accordance with the formal written Decree of Dissolution of Marriage signed by the Court on July 12, 2006 and filed by the Clerk on July 12, 2006.
