**IT IS ORDERED** that Mother shall have sole physical and legal custody of the parties' minor children, Madison Kaye McVeigh (DOB: 05/14/03) and Finley Rose McVeigh (DOB: 03/13/05) and there shall be no parenting time for Father until he physically appears before this court.

**IT IS FURTHER ORDERED** converting the Status Conference set for **September 11, 2007 at 9:30 a.m.** to a Default Hearing. If Father does not appear the court will enter a default decree. If Father appears, the court will consider the hearing a trial and try whatever issues are to be tried.

With respect to child support,

**IT IS ORDERED** that Father shall pay Mother \$1,374 per month as and for temporary child support, plus \$2.25 per month as and for the Clearinghouse Handling Fee for a total of \$1,376.25 per month, effective August 1, 2007. All payments shall be paid through the Support Payment Clearinghouse, P.O. Box 52107, Phoenix, AZ 85072-2107.

Mother's counsel shall notify the court upon discovery of Father's place of employment and a wage assignment shall issue to Father's employer. Father, likewise, is provided a Current Employer Information form with his copy of this minute entry to submit to the court to begin the wage assignment.

**ISSUED:** Judgment Data Sheet

Until a wage assignment becomes effective, it is the responsibility of the party obligated to pay child support to pay the support through the Support Payment Clearinghouse. The payment should include the case number and/or ATLAS case number, the name of the party paying support, and the name of the party who will receive the payment.

If payments are made directly to the person who is to receive the support, the payments may be considered a gift and no credit will be given towards the support obligation.

Any change in the paying party's employment and any change in the residential address of either party must be submitted to the Clerk's Office, in writing, within 10 days of the change (A.R.S. §25-322(C)). Failure to notify the Clerk's Office of any change may be considered contempt of Court.

**IT IS FURTHER ORDERED** directing the courtroom clerk to update Father's address in ICIS as stated this date on the record in open Court.
