IT IS ORDERED awarding Mother sole legal custody of the minor child, **Isaac N. Bowser (DOB: 4/09/1998)**.

IT IS FURTHER ORDERED that Father shall have parenting time every other weekend from Friday at 7:00 p.m. until Sunday at 8:30 p.m., beginning Friday, August 17, 2007, conditioned on Father not being involved in any illegal activity or endangering the minor child's welfare.

Discussion continues with the Court regarding the validity of Father's driver's license.

LET THE RECORD REFLECT that the Court takes judicial notice of Father's Lucas County, Ohio criminal cause matter.

IT IS ORDERED directing Father to contact the Arizona Department of Motor Vehicle, within ten (10) days, to advise that department of the suspension of his driver's license in Ohio and to clarify the status of his Arizona driver's license.

IT IS FURTHER ORDERED directing Father to obtain from the Arizona Department of Motor Vehicle a written statement of the status of Father's Arizona driver's license and submit said statement to the Court.

IT IS FURTHER ORDERED that Father's wife, Semira Bowser shall provide all transportation for Father's parenting time until further order of the Court.

Discussion continues with the Court regarding child support.

IT IS ORDERED directing Father to contact Ms. Hipple regarding his child support and arrearages.

IT IS FURTHER ORDERED referring this case to the IV-D Commissioner to conduct a status conference regarding child support issues in this case.

The parties will receive a minute entry from the IV-D Commissioner setting forth the necessary status conference information.
