Based upon the matters presented herein,

THE COURT FINDS that application of the Arizona Child Support Guidelines is inappropriate or unjust. The Court has considered the best interest of the children in determining that a deviation is appropriate. After deviation, the Child Support Order is **\$0.00**. Further, the parties have made an agreement in open court free of duress and coercion to deviate with knowledge of the amount of child support that would have been ordered under the Guidelines but for the agreement.

IT IS ORDERED awarding joint legal custody of the minor children, all in accordance with the formal written Parenting Plan adopted by the Court on August 9, 2012 and filed by the Clerk on August 9, 2012.

IT IS FURTHER ORDERED that the minor children will be in the care of each party according to the terms of the parenting time schedule as set forth in the Parenting Plan filed herein.

IT IS FURTHER ORDERED granting the *Petition for Dissolution of Marriage* filed on *March 1, 2012*, all in accordance with the formal written Order signed by the Court on August 9, 2012 and filed (entered) by the Clerk on August 9, 2012.

The Court's further findings and orders are as contained in the formal written *Decree of Dissolution of Marriage* signed by the Court.
