- 4) Mother shall have parenting time on Thanksgiving, November 28, 2002.
- 5) Mother shall add Father's name to the minor children's school records.

sanctions being imposed, which may include the granting of the relief requested by the other party, or the issuance of an arrest warrant.

The parties shall exchange with each other and present to the court the following documents:

1. An updated affidavit of the current financial circumstances pursuant to Rule 6.4b, Local Rules of Maricopa County;

2. If applicable, a child support worksheet completed pursuant to the Statewide Child Support Guidelines. If a jointly prepared worksheet is not filed, each party shall file a completed child support worksheet;

3. If there are disputed custody or visitation issues, a proposal for custody and visitation;

4. A proposed disposition of each issue before the court;

5. If there are disputed division of property issues, a current and detailed inventory and monetary valuation of the property and assets of the parties.

IT IS FURTHER ORDERED that the parties shall meet at least one week before the aforesaid hearing and attempt to resolve the issues.

IT IS FURTHER ORDERED the parties shall confer prior to the hearing regarding exhibits to be marked for the hearing. The parties shall present any exhibits and an exhibit inventory to the clerk of this division for marking no later than **three business days prior to hearing**. All exhibits presented shall have been exchanged between the parties. Duplicate exhibits shall not be presented.
