LET THE RECORD REFLECT that Mother's supervised parenting time with court-appointed supervisor, Francine Miller, has been suspended due to Mother's claims of an undisclosed illness.

LET THE RECORD REFLECT that this matter is a IV-D matter.

Father is heard and states that Mother failed to appear for a Review Hearing before the IV-D Commissioner, Hugh Hegyi, scheduled today at 8:30 a.m. The hearing was vacated. Father states that Mother's last supervised visitation with the child was on September 7, 2005.

Discussion is held regarding the Court-appointed facilitator/supervisor, Francine Miller.

Discussion is held regarding Mother's alleged physical conditions.

IT IS ORDERED that Petitioner/Mother provide information (source documentation from a health care provider) concerning her illness and her medications, as directed to do by Francine Miller, to Ms. Miller and to Father prior to her parenting time being reinstated and prior to the next scheduled Court proceeding.

Father is heard in response and requests the Court order that if/when supervised visitation resumes, that the visits take place at Parenting Skills Program as set forth in the Decree of Dissolution (if the parties cannot agree otherwise).
