IT IS FURTHER ORDERED that **Plaintiff-Appellant** provide both **Defendant-Appellees** with a copy of this minute entry.

IT IS FURTHER ORDERED that **Plaintiff-Appellant** shall file a notice of action as required by A.R.S. § 13-904(B).

IT IS FURTHER ORDERED that **Plaintiff-Appellant** shall order and make arrangements to pay for the preparation of pertinent portions of the record as required by A.R.S. § 12-904(B)(5).

IT IS FURTHER ORDERED that any answers from **Defendant-Appellees** shall be due 20 days from the date of service of **Plaintiff-Appellant's** complaint.

Plaintiff-Appellant is advised that, if **Plaintiff-Appellant** fails to effectuate service or to order the record or the transcripts as ordered herein, this Court may dismiss these proceedings.

IT IS FURTHER ORDERED that the administrative agency or board shall transmit its record to the Clerk of this Court as required by A.R.S. § 12-904(B) and provide a Certification of Record on Review to **Plaintiff-Appellant** and a notice to this court that the transmittal has occurred.

IT IS FURTHER ORDERED that **Plaintiff-Appellant** and **Defendant-Appellees** are to file briefs in accordance with Rule 6 of the Rules of Procedure for Judicial Review of Administrative Decisions.
